ALL WORK MUST BE ORIGINAL IN DESIGN AND THE WORK OF THE EXHIBITOR. Copies of others artwork, copyrighted photos, decorative kits, commercially purchased objects are not acceptable. THIS IS NOT A BUY/SELL SHOW. Any misrepresentation will be cause for dismissal from the fair. A qualified jury will select up to 200 artists and crafters to participate. Applicants must fill out the enclosed Wisconsin Sellers Permit form and return it with the lower part of the application. APPLICATIONS RECEIVED WITHOUT THE FORMS, PHOTOS AND A SELF ADDRESSED STAMPED ENVELOPE WILL BE RETURNED  
Pets are not allowed at the show.

**EXHIBITION MATERIALS AND SPACE:** Participants must supply own exhibition material for a 12' x 12' single display space, 12' x 24' double display space No gasoline generators allowed. spaces will be pre-assigned and will not be disclosed until registration the day of the show.

**ENTRY FEE:** The entry fee is \$200.00 for a single space or \$400.00 for a double space. NO OTHER CITY FEES ARE APPLICABLE FOR THIS SHOW. No commission will be charged for sales. Make checks and money orders payable to Wis. Dells Art Assoc.

**DEADLINE** Send the application, entry fee, photos, Wis. Sellers Permit and a stamped, self addressed legal size envelope. All applications must be received by MAY 30, 2024. Late applicants will be charged an extra \$50.00 fee for all applications sent after JUNE 15, 2024. Checks will be deposited on June 15, 2024. Participants will be notified by June 30, 2024 by mail whether or not they have been accepted. If not accepted entry fee and photos will be returned. It is the applicants responsibility to know whether their check has cleared by June 30, 2023.
